ELIGIBILITY:

- Must be at least a High School Senior and 18 years of age by January 1st of the current year
- Contestants may be male or female
- Must have a genuine interest in promoting the Crawford County Fair & be an exhibitor during his/her reign
- Attend the Interview and Judging process held on the 1st Friday of November at the Crawford County Administration Building in Prairie du Chien. All applicants must attend this interview or forfeit their position in the Fair Ambassador contest.

The purpose of the Crawford County Fair Ambassador is to serve as a year around representative for the Crawford County Fair. The Fair Ambassador will fulfill the duties and strive to reach the Goals set by the Crawford County Fair Ambassador Committee. The Fair Ambassador will promote fair attendance, sponsorship of and exhibition at the fair, focusing on agriculture and youth involvement in the fair.

THESE GOALS WILL BE ACHIEVED BY:

- Attending all days of the Crawford County Fair. Ambassador will be responsible for helping in various ways including but not limited to: attending judging, Meat Animal Auction, grandstand events, etc.
- Attending community events such as the Dairy Breakfast, Community Festivals, parades and others as required by contract.
- Speak to youth groups, including but not limited to: 4-H Clubs, Scout Troops, FFA Chapters, etc.
- Organizing off season events for the Fair Ambassador, Future Fair Ambassadors and any applicable attendants
- Attend meeting required by contract
- Prepare radio spots and press releases promoting the Crawford County Fair

- Represent Crawford County in the completion for the Wisconsin Association of Fairs, Fairest of the Fairs in early January

JUDGING:

- Interviews will be held on the 2nd Friday in November at the Crawford County Administration building at 5:30 pm, unless notified of a change
- Applicants will be interviewed by a panel of Judges
- Attendants will be selected at the discretion of the Judges and the Fair Ambassador Committee

TO APPLY:

- Fill out application
- Prepare a resume
- Write an essay answering questions provided on this application
- Write a complete self-bio to be used on the Fair website and for other media promotions
- Apply by the fourth Wednesday in October

ESSAY QUESTIONS:

- What is your current involvement in the Crawford County Fair?
- What assets do you possess that would make you a good representative of the Crawford County Fair?
- What do you want to serve as the Crawford County Fair Ambassador?

The Fair Ambassador is required to be a Crawford County Fair Exhibitor during the year of his/her reign.

If all expectations are met, the Ambassador will receive a \$250 cash prize sponsored by the Friends of the Fair Committee. The Friends of the Fair will determine if expectations are met.
