

## Animal Health Regulations

## for Fairs and Shows in Wisconsin: 2019 Season

This is a summary of animal health requirements for fairs, shows and exhibitions only. They are not necessarily the same as requirements for importing animals into Wisconsin or moving them within the state for other purposes. General	All fairs or exhibitions of any length must obtain, review, and keep for five years all required
Requirements	records and test results:
for show	Exhibitor's name and address
organizers	Animal identification (number, type, description)
	<ul> <li>Documents showing compliance with disease testing, identification, and other health requirements</li> <li>Livestock premises number, if any, where animals originated</li> <li>If requested by the fair or show organizer, the documentation showing legal importation (if applicable) and movement to the event</li> </ul>
	Fairs or exhibitions lasting more than 24 hours must appoint a licensed veterinarian to inspect all animals daily and review the above required records.
Diseases	Animals that show evidence of having contagious or infectious diseases may not be commingled (or housed/kept) with other animals at a fair, show, or other exhibition in such a way as to allow disease to spread. Such animals should not attend the fair, show, or exhibition. Animals may be denied entry if they arrive at these events with contagious or infectious diseases, isolated and/or removed if they develop disease after arriving, or be subject to other action as would be necessary to control disease.
	Bovine animals with ringworm, mange, warts or scab will be removed from the fair or exhibition premises, unless the veterinarian in charge finds warts or ringworm lesions are incapable of transmitting disease.
Cattle and	Cattle from within Wisconsin have no requirements for tests or health documents.
bison	Cattle from outside Wisconsin must:
	<ul> <li>Be accompanied by certificate of veterinary inspection (CVI or health certificate) documenting official animal identification (ID) and all required tests and certifications</li> <li>Have at least one form of official individual ID (including steers)</li> <li>Meet all of Wisconsin's normal requirements for import (see <a href="https://datcp.wi.gov/Pages/Programs_Services/CattleBison.aspx">https://datcp.wi.gov/Pages/Programs_Services/CattleBison.aspx</a>)</li> </ul>
	<ul> <li>Acceptable animal IDs for all cattle from outside Wisconsin</li> <li>USDA metal ear tag number that is part of the National Uniform Eartagging System (NUES) (starts with state 2-digit code, also known as "brite" tag); this includes the orange brucellosis vaccination tag</li> <li>15-digit "840" tags (visual or RFID)</li> <li>Valid only if applied before March 11, 2015: <ul> <li>Manufacturer-coded RFID tag - 15-digit number with the first three digits in 900s</li> <li>American ID tag - 8 to 12-digit number prefaced with "USA"</li> </ul> </li> </ul>

	<ul> <li>To originate from a herd that has a negative whole-herd TB test within 12 months before arrival in Wisconsin that includes all animals 1 year and older</li> <li>Negative individual TB tests within 60 days before entering Wisconsin</li> </ul>
	<ul> <li>To return directly to the state of origin after the show, and there must be a statement on the CVI that they will be doing so</li> </ul>

Swine	Swine from within Wisconsin need a Wisconsin intrastate certificate of veterinary inspection (CVI or health certificate):
	• Stating that the entire herd of origin was inspected on the farm within 30 days before the
	<ul> <li>show and showed no signs of disease.</li> <li>Non-terminal Exhibitions: All swine must have a PRRS (Porcine Reproductive and Respiratory Syndrome) and PEDv (Porcine Epidemic Diarrhea virus) test of the herd of origin within 90 days of the exhibition. Include test date, type, and results on the CVI. For swine originating from herds with positive tests, include the herd plan number on the CVI.</li> <li>Terminal Exhibitions: No testing requirements.</li> </ul>
	<b>Note:</b> Terminal Exhibitions are those at which the swine go directly from the fair/show to the slaughtering establishment OR to a slaughter only market sale. If going to a slaughter only market sale, contact the Division of Animal Health fair inspector for required information to collect.
	Swine from outside Wisconsin need a certificate of veterinary inspection that includes the following:
	<ul> <li>The negative results of the PRRS test from the swine's herd of origin conducted within 90 days prior to movement into Wisconsin including test date, type, and results.</li> <li>The negative results of the PEDv test from the swine's herd of origin conducted within 90 days prior to movement into Wisconsin including test date, type, and results.</li> </ul>
	<ul> <li>A statement that the veterinarian has inspected the entire herd of origin within the past 30 days and that no clinical signs of PRRS and PEDv or any other apparent disease was present at the time of inspection</li> </ul>
	Official individual identification (ID)
	If the herd of origin tests positive for PRRS and/or PEDv, contact the Department of Agriculture, Trade and Consumer Protection at 608-224-4872 for options.

Swine (cont.)	<ul> <li>Acceptable methods of ID for swine are:</li> <li>USDA silver ear tag</li> <li>USDA 840 ear tag, either visual or RFID</li> <li>Breed association tattoo if the pig is a purebred and the tattoo is registered</li> <li>An ear tag with the premises identification number and a unique identifier</li> <li>Ear notch if the pig is a purebred and the notch is registered</li> <li>Requirements are subject to change as conditions warrant. Sheep and goats	<b>Note:</b> These rules do not apply to non-domestic sheep and goats. For these animals see the section on Exotic ruminants below.
	<ul> <li>Sheep and goats from within Wisconsin need:</li> <li>If sexually intact, need official individual identification (ID) at any age</li> <li>If not sexually intact, need official individual ID if they are 12 months or older</li> <li>Official ID includes scrapie ear tags or tattoos, USDA 840 ear tag, approved microchips if a reader is available and if accompanied by breed registration papers in the owner's name, or breed association tattoo if accompanied by registration papers in the owner's name</li> <li>Cannot be under restriction for movement to fairs and shows</li> <li>Sheep and goats from outside Wisconsin need:</li> <li>Certificate of veterinary inspection (CVI or health certificate) and official individual ID: scrapie ear tags or tattoos, USDA 840 ear tag, approved microchips if a reader is available and if accompanied by breed registration papers in the owner's name, or breed association by the papers in the owner's name is available and if accompanied by breed registration papers in the owner's name, or breed association tattoos, USDA 840 ear tag, approved microchips if a reader is available and if accompanied by breed registration papers in the owner's name, or breed association tattoo if accompanied by breed registration papers in the owner's name, or breed association tattoo if accompanied by registration papers in the owner's name.</li> </ul>

South American camelids: Ilamas,	<ul> <li>The animal remains in Wisconsin no longer than 7 days</li> <li>Proof of a negative EIA test in previous 12 months accompanies the animal Requirements are subject to change as conditions warrant. Official ID may be:</li> <li>Approved USDA ear tag number</li> </ul>
alpacas, guanacos, vicuñas	<ul> <li>Microchip number</li> <li>Breed association registration number</li> <li>Breed association tattoo</li> <li>Requirements are subject to change as conditions warrant. Exotic Ruminants	<b>Note:</b> Exotic ruminants are ruminants that are not native to Wisconsin, and are not cervids – for example, Old World camels, yaks, water buffalo, pronghorn antelope, giraffes, and non-domestic sheep and goats. In addition, please contact your county and local municipality for any restrictions.
	<ul> <li>Exotic ruminants from within Wisconsin have no requirements.</li> <li>Exotic ruminants from outside Wisconsin must have <ul> <li>Certificate of veterinary inspection (CVI or health certificate)</li> <li>Official individual identification (ID) (one of the following) <ul> <li>Approved USDA ear tag number</li> <li>Microchip number</li> <li>Breed association registration number</li> <li>Breed association tattoo</li> </ul> </li> <li>Import permit</li> <li>Proof written on the CVI that they meet requirements for: <ul> <li>Tuberculosis (TB) – negative test required within 60 days before entry</li> <li>Brucellosis – negative test required within 30 days before entry</li> </ul> </li> </ul></li></ul>

Poultry and waterfowl (Pigeons are not considered poultry for fairs and shows)	<ul> <li>Poultry and waterfowl from within Wisconsin need:</li> <li>A NPIP certificate stating that the birds originate from a US pullorum-typhoid clean or NPIP affiliate flock and turkeys must test negative for <i>Mycoplasma gallisepticum</i>, or</li> <li>A DATCP-issued certificate stating they are from a Wisconsin Tested or Associate Flock and turkeys must test negative for <i>Mycoplasma gallisepticum</i> or</li> <li>Individually test sexually mature birds within 90 days before arrival at the show. These birds also need wing or leg band identification (ID). All birds must test negative for pullorum-typhoid, and turkeys must test negative for <i>Mycoplasma gallisepticum</i>.</li> </ul>
	<ul> <li>Poultry and waterfowl from outside Wisconsin need a certificate of veterinary inspection or equivalent (such as form VS 9-3) that states:</li> <li>They originate from a flock classified pullorum-typhoid clean under NPIP or an equivalent state program and turkeys must test negative for <i>Mycoplasma gallisepticum</i>, or</li> <li>If they are sexually mature, that they have tested negative for pullorum-typhoid (and <i>Mycoplasma gallisepticum</i> for turkeys) within 90 days before arrival at the show. These birds also need wing or leg band ID.</li> </ul>
	<ul> <li>Not required:</li> <li>Import permit number</li> <li>Requirements are subject to change as conditions warrant. For current information, check</li> </ul>

Small animals: Dogs, domestic cats, and other	<ul> <li>Note: For animals that are part of menageries, see also rules below for menageries. Pot-bellied and miniature pigs fall under rules for swine. Dog hybrids, domestic cat hybrids, or exotic small cat species such as servals fall under rules for Exotic small animals. Native wild animals and birds, including raptors, and captive wild animals such as raccoons, opossums, and skunks fall under rules for wild animals.</li> <li>Dogs from within Wisconsin that are 5 months or older need proof of current rabies vaccination.</li> </ul>
household pets	Cats and other household pets from within Wisconsin have no requirements.
(ferrets, pet birds, rabbits, gerbils, guinea pigs, hamsters,	<b>Dogs and cats from outside Wisconsin</b> that are 5 months or older need to be vaccinated for rabies by a licensed veterinarian, and regardless of age, need certificates of veterinary inspection (CVIs or health certificates) stating the age of the animal and for animals 5 months and older the date of last rabies vaccination and revaccination due date.
domestic mice and rats)	Other household pets from outside Wisconsin need certificates of veterinary inspection (CVIs or health certificates) but have no testing or vaccination requirements. Small animals from other nations need to meet requirements of the U.S. Department of Agriculture (608-662-0600) and Centers for Disease Control (1-800-232-4636).

Guidelines	The State Veterinarian recommends that exhibitors:
for housing and	<ul> <li>Vaccinate breeding cattle against bovine viral diarrhea (BVD) at least 30 days before the event</li> </ul>
managing animals	<ul> <li>Test cattle for BVD-PI by immunoperoxidase test, and bring them to shows only if they test negative</li> </ul>
	<ul> <li>Test cattle for Johne's disease by ELISA test, and bring them to shows only if they test negative</li> </ul>
	<ul> <li>Clean and disinfect vehicles used to transport animals to and from the show, and vehicles used on the grounds before, during, and after the show</li> </ul>
	<ul> <li>Isolate exhibited animals returning to their farms or animals purchased at the show for 21 days before mingling them with other stock</li> </ul>
	The State Veterinarian recommends that show organizers:
	House cattle separately from South American camelids and other exotic ruminants
	House cattle separately from small ruminants, especially sheep
	House ostriches, emus, rheas and cassowaries separately from domestic poultry
	House swine separately from any other mammals
	<ul> <li>Include a space for the premises registration code on livestock entry forms</li> </ul>
	Provide hand-washing stations near all livestock facilities
	Provide individual watering and feeding troughs rather than common ones
